

Fire Alarm System Update

I personally want to thank the dozens of dedicated staff, volunteers and firemen from local fire departments for assisting us in March with our fire watch. We are humbled by the outpouring of support and assistance we received during that time.

I am thankful that we have been able to suspend our fire watch now that our system has stabilized and is back to normal. Even though the system is back to 'normal,' we believe there are still deficiencies in the current system that need addressed.



In response to this, we have contracted with Koorsen Fire & Security out of Fort Wayne to perform a total system replacement. As of Monday, March 30th, this new system replacement process has begun. Thank you in advance for your patience and cooperation during this project. We anticipate this project to take approximately three months to complete.
